Class "B" /"C" Shooter's Safety Rules and Notes- Please Read!: The club can provide mortars for shooting display shells in of various sizes in HDPE plastic, as well as steel, for multi-break shells only. At present we have no provisions for rocket racks, candle racks, or other pyro. It is suggested you bring at least one mortar for any size shells you will shoot, unless other arrangements are made with the Safety Team/Site Coordinator. Please contact the either of these groups if you do not have mortars for your shells, and we will try to obtain these prior to the event. All shells of 6" or larger should have visco fused leaders or be electrically fired to allow a safe retreat time after ignition. Only ONE shooter should be in the immediate firing area after a shell is ignited. Please ask one of the clubs Safety Officers what the procedure will be for open shooting when you arrive. Safety Officers wear Orange vests and badges indicating they are Safety. We will also discuss any issues you may have at the club meeting. There will be pressurized water fire extinguishers placed within the "B" and "C" areas. Look for them. Know where they are.

No guests or anyone under the age of 18 should be in the "B" setup areas at any time!

There will be an area set aside for shooting the "C" material. Please check with the club officers to see when and where this area will be open. All children shooting material should be carefully supervised by their parents.

We are always in need of volunteers for Safety assistants, supervision of the open shooting areas, sales, and security.

The cleanup fee charged as part of this registration is distributed evenly among any persons who help with clean-up on Sunday. Fill in the Safety Seminar Form, give it to the staff at registration, and attend the Seminar on Saturday. If you have questions please ask the Registration Staff or Safety Team.
